## Abstract

Indian roads are having petrol, diesel and CNG fuel vehicles. Electric vehicles are still on testing mode and initial phase of launching in India. Due to global warming, climate change issues and looking towards pollution in India, an electric vehicle becomes the vital need. Globally many automobile companies have launched electric vehicles and successfully running on their roads. An attempt has been made through this study to understand the readiness and preparedness of Indian auto industry and customers to welcome electric vehicles. A descriptive and quantitative study has been conducted. Results found that customers are aware about the electric vehicles. This study conducted with special reference to car segment of electric vehicle. Demographic factors, Price, eco-friendly, ease of driving, fuel cost etc were the factors affecting the perception of customers.

## Introduction:-

There is a paradigms shift in automobile industry. Climate justice and Climate change are the two buzz words across the world. World is talking about environment conservation through business activities. Emission of carbon is the main factor contributing towards imbalance of climate. There are many solutions over the climate change issues. One of the great solutions that rest of world is adapting is launching of electric vehicles.

In India also government have taken initiative by removing the obstacles in launching the electric vehicles. Indian companies as well as MNC's are on the verge of launching electric vehicles. In fact few brands have already launched electric vehicles in

India. Niti Aayog already proposed to push fully electric vehicles in two and three wheeler option by the year 2025. But at the other side looking towards Indian customers and their needs, it very difficult and challenging job to automobile industry to change their mindset for buying electric vehicles. Current scenario in automobile market brings a question in highlight whether Indian's are ready to accept and buy the electric vehicles in coming years?

With this objective current title Hs been chosen. Study also had a scope of studying customers buying decision, perception and factors affecting buying decision. It also studied the current potential for electric vehicles in India and major challenges in front of the industry.

**Literature Review:** Indian auto industry is the world's 5<sup>th</sup> largest industry producing variety of vehicles. It has been predicted that it will become 3<sup>rd</sup> largest by the year 2030. (Helge Tryati 2017) Comparing globally India has started late for electrification path. Hence it needs a strong government and industrial policies to match the speed and gear up. Government of India kept a vision of producing all new vehicles as electric vehicles by the 100<sup>th</sup> year of India's independence. (SIAM Report (2017)) As of now the market for electric vehicles in India is sluggish and there are numerous reasons for that. Major reason is of high price of the vehicles. It is up to 2 times the conventional vehicles available in the market. As of now India's market needs to improve their infrastructure. Like Home charging, public charging, Battery cell, etc. (Mr. A. Rakesh Kumar, 2019) Lithium Ion battery had huge prices earlier but from last few years cost of LI Ion batteries are falling consistently. It may help to reduce the prices of electric vehicles. Its prices are consistently decreases from \$200 kwh and expected to decrease up to \$70 kwh by the year 2030. (Prof. Ashok Jhunjhunwala, 2019) If we see the figures in 2018 1200 electric cars and in 2019 total 3200 electric cars were sold in India. Three wheelers (electric) were in more demand as the total sale in 2019 was observed as 6,30, 000 electric vehicle.(SMEV,2019). Structure of electric vehicle is very simple as battery is the main energy storage. Battery will decide the success of electric vehicle in any country. (K.W.E CHENG,2009).

Public attitude towards electric vehicle use was positively associated with intention of buying the vehicle. As well as perceived usefulness was observed associated with perception of EV's, attitude towards EV's, intention to buy EV's and ease of use it (Eunil Park,2018). Author observes some factors influencing electric vehicle adoption. Those considered factors were knowledge of cleaner and green technology, purchasing cost, charging time, maintenance cost, financial benefits, demographic

factors etc. (Simona Bigerna and Silvia Micheli, 2018). While buying electric vehicle especially during buying car, Brand plays an important role. Most of the respondents in the research feel that electric vehicles will dominate the market. Respondents replied that they will buy the electric cars because it does not emit carbon as well as it will be highly efficient and low maintenance cost (Masurali. A, Surya P, 2018). Authors conducted a survey regarding awareness of electric cars in India. It has been found that majority of the respondents in India were aware that electric vehicles reduce emission of carbon and contribute for improvement in climate change (Mifzala Ansar, Monika B.A,2019). Factors influencing buying behavior of electric vehicles were studied by the author and observed that there were internal and external factors impacting. They were related to utility, and ease of use, attitude of consumers towards electric vehicles, behavioral intention (Chun & Yang 2019).

Recent development in EV's was studied through the research paper. It was focusing on charger design, motor, battery technology, steering system and braking system etc. (K.W.E CHENG, 2009). Mobility and recharging factors found very important in buying intention of electric vehicles. RTO norms were considered as least significant factor. People's attitude was found positive towards ease of use, fuel saving, eco friendly, user friendly, pollution free and smooth navigation etc.(Bharti Motwani, 2019). Researcher found a fissure among domestic crude oil requirement and production. As well as India is 7<sup>th</sup> largest carbon emission country. Therefore there is a need of green vehicles using electricity as a fuel. mahindra, maruti suzuki, bmw, tata motors are the brands delivering electric vehicle in the recent time in India. (Pritam K., Varsha, Makarand, 2018) Researcher studied drivers and barriers in the adoption of plug-in electric vehicles. Factors studied were speed, noise, look and style of the car, availability of

charging stations in public, cost of vehicle, potential cost saving, government regulations, fuel infrastructure, finance incentives to car buyer etc. (Johan, Rezvani and Bodin 2015). Perception and purchase intention of buyers was studied by the researchers. Factors discussed were environmental cost, advancement in technology, availability of infrastructure, social advancement etc. Government roles, environmental policies, subsidized cost of electric vehicles, bank rate of interest were some other factors discussed. (Pretty, Inass Salamah, 2018)

From the literature it has been observed that India have started late in electric Car production. Government's role is very important in the progress of EV's production. Infrastructure in India observed one of the major challenges. But most of Indian researchers have done the research in point of view of infrastructure preparedness and government's role. There are very less number of research in point of vies of customers perspective and their buying decisions. This has been observed as a research gap and hence the topic has been chosen.

**Objectives of the Study:-**

Objective of the study are as following

1. To understand the awareness level of electric vehicles among customers
2. To find out the attitude and intention to buy electric vehicles (Car).
3. To assess customers buying perspective for electric vehicles.

4. To analyze different factors affecting on consumer buying decision of electric vehicles (Car).
5. To analyse the challenges for electric vehicles in Indian automotive market

**Hypotheses:-**

**H<sub>1</sub> :- “Demographic factors affect the buying intention of electric car”**

**H<sub>2</sub>:- “Buyers perception is associated with Buying Intention of electric car.”**

**Research Methodology:-**

Current study was conducted through the survey to understand the characteristics of the population. Hence researcher has used **Descriptive Research Design**. Data collection was related with primary as well as secondary sources. Literature review was carried out through Secondary data. It was collected from research papers, websites, reports and blogs etc. Primary data was collected from a structured questionnaire using different scaling techniques as it was mainly focusing on respondent's attitude and opinion etc.

Convenience sampling was used in the study. Total 423 respondents involved in the study. These respondents were representative of different geographical areas and different states of India. Data analysis was done using SPSS by using hypothesis testing statistical tools like chi-square test, t-test and standard deviation.

Demographic details explore that majority of the respondents were male (81%) followed by female (19%). From the respondents involved in the study, majority were from the younger age. 39% of the respondents belong to age group middle age group i.e. age 35 to 45, followed by the age group of 25 to age 35 with 30% of the respondents. Salaried respondents

were observed more as compared with retired and other category. After salaried, businessmen (29%) were involved in the study. Respondents from the 5 to 10 lakh income group (55%) were observed more followed by the respondent's income of 10 to 15 lakhs (30%).

$\chi^2$ - test was run for understanding the relationship between demographic factors and their objective to buying the electric cars in future. Intention of buying electric car was measured with a five point likert scale along with four demographic factors namely gender, age, occupation and income. When gender and buying intention was associated it has been observed that p-value for gender (0.000), Age (0.0029), Occupation (0.0034) and Income (0.0057). All the factors were

tested with 95% of confidence level and 5% of significance level. All the p-values related with demographic factors were observed less than 0.05. Hence alternative hypothesis is accepted and null hypothesis i.e. "There is no relationship between demographic factors and buying intention of electric cars" is rejected. Therefore it can be inferred that there is an affirmative relationship between demographic factors and buying intention to buy electric car.

standard deviation values reflects that there is a less deviation between the mean values and actual responses as it is less than 1. Therefore it can be observed that there is a sound awareness about electric vehicles.

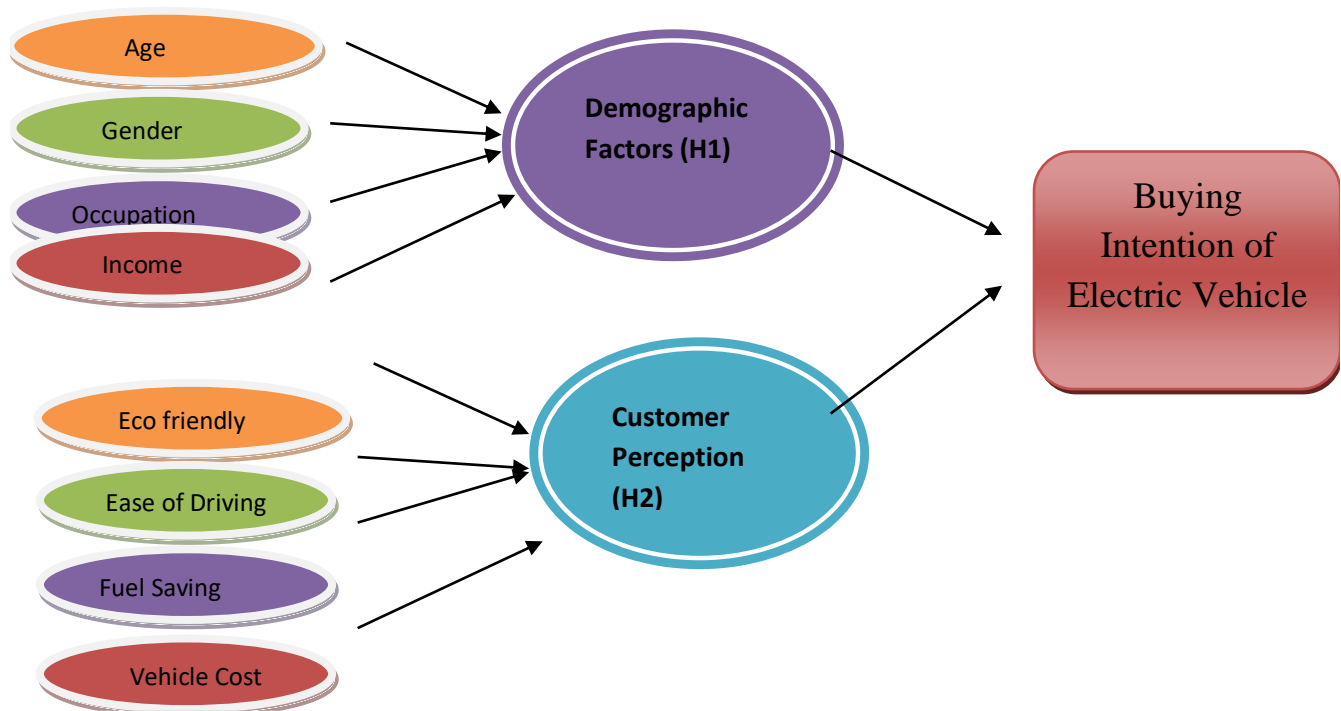

Customers were asked if in future planned to buy the electric car, then what would be their choice. Table no.5 reflects that 52% of the respondents were in favor of Indian brands and 48% of the respondents in favor of foreign brands.

Among the Indian auto players both Maruti and Mahindra were the choice of approximately equal respondents i.e. 39% and 38% respectively followed by Tata motors with 23% respondents.

**Findings:-**

From the comprehensive research work it has been observed among total respondents male respondents were more comparing to female respondents. Research work was carried out with the respondents having varied demographic profile considering to age, income and occupation. Majority of the respondents were from salaried background (62%). Results depicts that demographic factors like age, gender, occupation and income have the positive relationship with buying intention of electric cars. Respondents were very well aware about the electric cars, their need and utility. Buyer's perception towards EV's was observed as positive. Eco-friendliness, fuel saving, pollution free,

more mileage, ease of driving the attributes of EV's makes this positive attitude of the respondents. Data analysis found that respondents were more in favor of Indian electric cars comparing to foreign brands.

**Conclusion: -** Today an Electric vehicle became the necessity. Climate change is a serious issue in front of all the nations in this world. Carbon emission should be reduced to solve this problem. Introducing electric vehicles would be one of the solutions for reducing carbon emission. Though today the prices of electric vehicles are costly, still slowly and steadily these prices will be minimized by governments various initiatives. Respondents replied that subsidy in buying electric vehicle would play an important role to

motivate the people for buying the electric vehicles. There is a great need of development in the infrastructure for electric charging stations. From the perception of the respondents and their choice of buying electric vehicles, it has been observed that there is a great scope for electric vehicles in Indian automotive market. Respondents given preferences for Indian brands like Tata motors, Mahindra and Maruti Suzuki for buying electric vehicles. Electric vehicles- **Car** segment was observed more in demand. Though as of now customers are not ready with their money pocket but still there is a desire in their thought to purchase the electric vehicle. Overall it can be concluded from the data analysis that there is a huge demand for electric vehicles in coming future time.
