- 3) **10% Discount** on Laboratory & Radiology Investigations on prevailing Hospital Tariff in outpatient department (OPD).
- 4) **5% discount** on Outpatient department Pharmacy Bills

IPD:-

- 5) **10% Discount** on In Patient department (Excluding Consumables, Packages, Medicines & Doctor fees) on prevailing Hospital Tariff in following criteria :
 - a) Bill to Company, Credit Bills,
 - b) Cash payment by Corporate Employees and Dependents.

Health Checkup:-

- 6) **10 % Discount** on Health Checkup packages as per ABMH wellness brochure.

- 7) The discounts mentioned out under clause- 2, 3, 4, 5 & 6 shall not be applicable for Patients who are covered under the Medical Insurance Policy/TPA.



MEMORANDUM OF UNDERSTANDING

- 1) Aditya Birla Hospital would be providing Out Patient department & In Patient department Health services to the beneficiaries of **Jayawant Shikshan Prasarak Mandal**.
- 2) **Jayawant Shikshan Prasarak Mandal** Students, Staff & Staff Dependants should carry respective institute ID card or an authorization letter from the authorized personnel of their institute or an email from the authorized personnel prior arrival to the Hospital.
- 3) For Staff Dependants: They have to carry a Xerox of Employees ID Card or Employee accompanying with the dependant with ID card or an authorization letter from the authorized personnel of their Institute or an email from the authorized personnel prior arrival to the Hospital.
- 4) Credit facility for **Jayawant Shikshan Prasarak Mandal** Students, Staff & Staff Dependants for In Patient department, Out Patient department letter from the institute or mail is mandatory (The expenses will be billed to institute on the receipt of email from Prof. S. L. Bhilare & Mr. Prashant Hambar). Credit facility users can avail the above Discount structure.
- 5) In case of emergencies your beneficiaries would require to produce the letter within 24 hours of the next working day from the time of admission.
- 6) In case any individual Students, Staff & Staff Dependants opts for higher category accommodation than his/her entitlement, then the difference of the entire charges of the higher category has to be borne by the Students, Staff & Staff Dependants in case at the time of discharge.
- 7) Bills for the hospitalization should be settled by **Jayawant Shikshan Prasarak Mandal** within 30 days of receipt of bills in your office. Accounts which are remaining unsettled above 30 days shall be liable for a charge of 18% PA equivalent to the prevailing bank interest rates on advances. (The expenses will be billed to institute on the receipt of email from Prof. S. L. Bhilare & Mr. Prashant Hambar)
- 8) For cash payee Students, Staff & Staff Dependants, the corporate discounts would be extended to Students, Staff & Staff Dependants only upon producing a valid ID card of the institute and for their dependants - a valid authorization letter from their institute would be required.
- 9) The credit facility would remain suspended if accounts are not settled within the allowed credit period.



- 10) For all the indoor and outdoor treatment, payment should be made by cheque in favor of "Aditya Birla Health Services Ltd.- Collection A/c".
- 11) All the hospital charges shall be as per the prevailing hospital schedule of charges. Whenever there is any revision in the schedule, such revised schedule of rates shall be applicable from the date of such revision.

The charges of the Non Cardiac Ambulance will be for the first 3 kms will be Rs 500/- & there after each km will be charged @ Rs 50/km and the charges for Cardiac Ambulance will be for the first 10 kms will be @ Rs 1850/- and there after each km will be charged @ Rs 75/km.

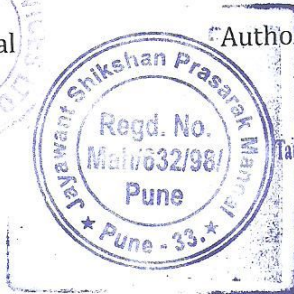
